RENTAL TERMS AND CONDITIONS

Renting a mobile-home or a camping pitch.

1. Reservation conditions: Reservation only becomes effective after:

- a. Receipt of the signed reservation form,
- b. Receipt of deposit: - **25% of the rental amount + 10 € reservation fee, for accommodation.**
- **60 € fixed amount, for camping pitches.**

2. Rental conditions of mobile-home/caravan/tent:

- a. During the months of July and August rentals are made by the week from Saturday to Saturday.
- b. The rental is available on the day of arrival from **3pm** and must be vacated on the departure day before **10am**.
- c. **The number of people** must not exceed the stated number for the type of rented accommodation.
A charge of 4€ per night and per extra person will be required for mobile-homes.
 - 29 m² from the 5th and 6th person.
 - 31 m² from the 7th and 8th person.

Any modification of number or identity of initially registered persons must be made known.

- d. **Full booking payment:** All bookings must be paid **1 month before arrival date without a reminder notice**. If the reservation is made in the 30 days before the booking start date, the rental booking must be paid in full. No refunds will be made in case of late arrival or departure.

- e. **A deposit** will be requested on the day of your arrival of 150 € guaranteeing loss, damages or damage to equipment.

The final cleaning of the accommodation is charged to the customer. A cleaning charge of 40€ can be billed if cleaning has not been correctly carried out. For all departures outside reception opening hours the cleaning charge is obligatory.

The 40€ cleaning charge can be paid on the day of your arrival if you do not wish to clean on leaving.

- f. **Cancellation:** Over a month before arrival date, deposits received are refunded to the customer if the cancellation is through the postal service. Administrative costs will be retained by the PELONIE campsite.

Less than a month before the scheduled arrival date, the total of sums already paid will be retained by PELONIE.

3. Conditions for camping pitches:

- a. Places are available on the day of arrival at 12pm and must be vacated on the day of departure by 12pm.

- b. **Full booking payment:** The day before your departure.

- c. **The number of people** must not exceed the stated number, a maximum of 6 people per pitch.

- f. **Cancellation:** Over a month before arrival date, deposits received are refunded to the customer if the cancellation is through the postal service. Administrative costs will be retained by the PELONIE campsite.

Less than a month before the scheduled arrival date, the total of sums already paid will be retained by PELONIE.

4. Animals: Vaccination logs are obligatory. They must be up to date. They will be requested at reception. Animals must not be left alone on the campsite under any circumstances. An extra 2€ per night and per animal will be requested.

5. Vehicle: One vehicle per accommodation or camping pitch. An extra 2€ charge will be requested per extra vehicle.

6. Visitors: are authorised under the responsibility of their host, after having informed reception of their presence and paying, if necessary, the 2€ fee.

7. The customer agrees to abide by the internal rules displayed on the campsite:

- a. Driving motorised vehicles is limited to 10km/h and is forbidden on the site between 11pm and 7am.

- b. From 11pm, it's obligatory to respect your neighbour's right to rest.

All customers are bound to abide by the internal rules of the camp site.
